SPECIAL VILLAGE BOARD MEETING

Call to Order/Roll Call – Village President Chad Coyier called this Special Village Board meeting to order at 6:03 p.m. Roll call was taken with the following members present: Zach Washa, Tom Cody, Tony Kaster, Dennis Richgels, John Kreul and Chad Coyier. Susan Washa was excused. Others present were Tom Hebgen and Becky Fredericks, Daniel Swinehart arrived at 6:15 p.m.

Certification/Compliance – Clerk certified that notice of meeting was posted on October 13, 2017. Z. Washa motioned as to compliance with open meeting law. Richgels seconded. Motion carried.

Discuss 5-year Capital Improvements Plan – take action, if necessary – Discussion was had to get a plan started using Neil Michek's plan as a beginning point. This will be worked on in the near future and will look at some ideas for the January board meeting.

Consider convening to closed session per Wis. Stats. 19.85(1)(c) to consider employment, promotion, compensation or performance evaluation data of any public employee over which the government body has jurisdiction — Kaster motioned to go into closed session at 6:42 p.m. Cody seconded. Roll call vote "Aye": Z. Washa, Cody, Kaster, Richgels, Kreul and Coyier. Motion carried.

Reconvene to open session to take action afore mentioned closed session – Cody motioned to reconvene to open session at 7:24 p.m. Z. Washa seconded. Roll call vote "Aye": Z. Washa, Cody, Kaster, Richgels, Kreul and Coyier. Motion carried. Coyier motioned to approve a 2% wage increase for only full-time employees. Kaster seconded. Roll call vote "Aye": Kreul, Richgels, Kaster, Cody, Z. Washa and Coyier. Motion carried.

Discuss 2017 Budget Line Item – Snow Plow – take action, if necessary – Tom Hebgen had a couple quotes on a F550:

- ❖ Fillback Ford & Grant County Truck Bodies 2018 F550 for \$68,316.84, it would be \$9,000 more to go hydraulic
- ❖ Monroe Truck Equipment 2017 F550 \$86,076.50 with a diesel motor and hydraulic, can deduct \$8,000 for gas motor

So in comparison for a gas motor engine and with hydraulics, Fillback is about \$77,000 for the 2018 F550 and Monroe Truck is about \$78,000 for the 2017 F550.

Richgels motioned to purchase the 2018 F550 with gas motor and electric controls and a snow plow and box from Fillback Ford not to exceed \$68,316.50. Kaster seconded. Roll call vote "Aye": Cody, Z. Washa, Coyier, Kreul, Richgels and Kaster. Motion carried. Tom Hebgen will supply the board with the final paperwork at the November board meeting.

Work on 2017 Amended Budget and 2018 Draft Budget - 2017 amended budget and 2018 draft budget were looked over with questions asked and answered.

Adjournment – Z. Washa motioned to adjourn at 9:39 p.m. Cody seconded. Motion carried.
